Mortgage Discounts: Mortgages are discounted using an imputed interest rate that approximates the rate that an independent borrower and lender would have negotiated in a similar transaction. New mortgages equaling approximately \$1.7 million were written and entered into in 2022 and were discounted to represent the present value of these zero interest loans. Imputed interest of 7.49% is used for mortgages in 2022.

ReStore Program: The purpose is to generate a sustainable source of income for HFHML by diverting usable building materials, furniture and appliances from landfills and selling those donated items to the public.
